CONSENT TO THE PROCESSING OF PERSONAL DATA

- 1. Personal data of persons participating in the Competition will be processed in accordance with the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 27, 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC (General Data Protection Regulation).
- 2. Huawei Polska Limited Liability Company with its registered office in Warsaw, ul. Domaniewska 39 A, 02-672 Warsaw informs that it is the administrator of the personal data of Competition Participants ("Administrator").
- 3. In order to properly protect personal data, the Administrator has appointed a Data Protection Officer who can be reached at the following e-mail address: dpo@huawei.com.
- 4. Participants' personal data will be processed only for purposes related to implementation the Competition, including the issue of prizes and to consider any complaints.
- 5. Providing personal data by the Participant is voluntary. Failure to provide personal data prevents the implementation of the Competition, the award or delivery of prizes in relation to such a person.
- 6. Personal data will be processed for the duration of the Competition and after its completion for the period of limitation of claims arising from applicable law.
- 7. The legal basis for the processing of personal data is:
 - 7.1. justified interest of the Administrator (art.6 par.1 lit.f RODO) including increasing the Huawei brand recognition, promoting Huawei products and building relations with Huawei customers by organizing the Competition and

7.2. legal obligations incumbent on the Administrator (art.6 par.1 lit.c RODO) - when the processing of data is necessary to meet the legal obligations to which the Administrator is subject, such as obligations arising from tax regulations regarding accounting and customs, GDPR or other legal provisions (e.g. transfer of personal data to authorities) and

7.3. consent granted (art.6 par.1 lit.a RODO) - in the scope of image preservation and dissemination.

8. The recipients of personal data will be: external entities supplying and supporting the Administrator's ICT systems, providing services related to current operations Administrator in the form of creative and marketing agencies - pursuant to relevant contracts entrusting the processing of personal data and ensuring the use by the abovementioned entities with adequate technical and organizational measures to ensure data protection.
9. Every person whose data is processed, to the extent resulting from legal provisions, has the right to access their data and rectify, delete, limit processing and the right to object to data processing as well as the right to transfer data.
10. Any person whose data is processed on the basis of consent is entitled to withdraw his consent at any time. Withdrawal of consent does not affect the compliance of the processing that was carried out on the basis of consent before its withdrawal.
11. Huawei may share Participant's data with companies from the Huawei group based in the People's Republic of China. The European Commission does not recognize the People's Republic of China as a state that provides an adequate level of protection. Therefore, Huawei group entities provide adequate security for personal data by applying standard data protection clauses adopted by the European Commission. In case of doubts related to the processing of personal data any person may request the Administrator to provide information. Notwithstanding the foregoing, everyone has the right to lodge a complaint with the supervisory body about the unlawful processing of personal data - the President of the Office for Personal Data Protection.
